



TERMS OF USE

BTS Asset Management, Inc., its subsidiaries and affiliates (collectively, “BTS”), requires all visitors to this website and the sites owned and operated by BTS on the World Wide Web, (collectively, the “Website”) to adhere to the following terms and conditions.

By accessing and/or using the Website and the information, content, forms, photographs, graphics, software or other products or services available by or through the Website (the “Content”), you acknowledge that you have read and agree to be bound by these Terms of Use (the “Terms”), and that, to the extent applicable, the Terms supplements your existing Client Agreement(s), if any, with BTS. Please read the following terms and conditions carefully.

- 1. Parties.** As used herein, the term “You” and “Your” shall mean You, individually, and each other party on whose behalf You may Use the Website at any time. All references to “We”, “Us” or “Our” shall refer to BTS. The Website is operated by BTS Asset Management, Inc.
